What is the purpose of this update?

This document tells you how the Europe Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Description of this fund

Invests in international shares and is designed to track the return (before tax, fees and other expenses) of the FTSE Developed Europe All Cap Index.

What are the risks of investing?

Risk indicator for the Europe Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets

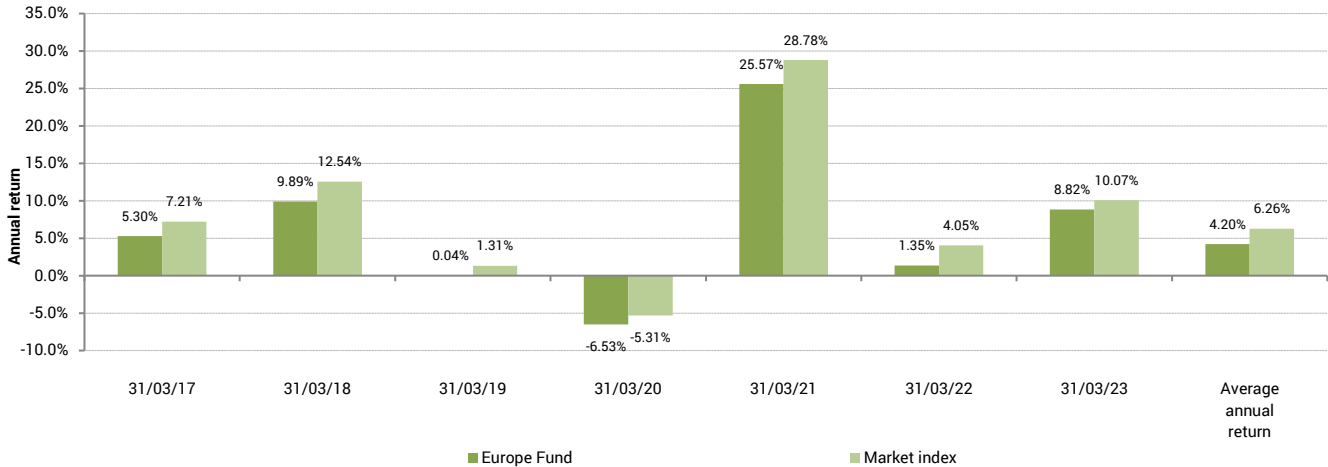
How has the fund performed?

What fees are investors charged?

Investors in the Europe Fund are charged fund charges. In the year to 31 March 2023 these were:

Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted of \$1,918 (that is 19.18% of her initial \$10,000). Jess paid other charges of \$12. This gives Jess a total return after tax of \$1,906 for the year.

Notes
