What is the purpose of this update?

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets




Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess incurred a loss after fund charges were deducted of -\$799 (that is -7.99% of her initial \$10,000). Jess paid other charges of \$12. This gives Jess a total loss after tax of -\$811 for the year.
