Fund update for the quarter ended 31 March 2023

This fund update was first made publicly available on 3 May 2023.

What is the purpose of this update?

This document tells you how the Total World (NZD Hedged) Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Total World (NZD Hedged) Fund invests in international shares and is designed to track the return (before tax, fees and other expenses) of the FTSE Global All Cap Index, 100% hedged to the New Zealand dollar.

What are the risks of investing?

Risk indicator for the Total World (NZD Hedged) Fund¹



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Note that even the lowest category does not mean a riskfree investment, and there are other risks that are not captured by this rating.



How has the fund performed?


Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess incurred a loss after fund charges were deducted of -\$822 (that is -8.22% of her initial \$10,000). Jess paid other charges of \$12. This gives Jess a total loss after tax of -\$834 for the year.

Currency hedging

The fund's foreign currency exposure is hedged to the New Zealand dollar. The target hedging level is 100.00% of the fund's foreign currency exposure. The actual hedging level can be anywhere in the 0% - 120% range. As at 31 Mar 23, 99.31% of the fund's foreign currency exposure was hedged. Notes

- 1 Market index returns (as well as actual returns) have been used to complete the risk indicator, as the fund has not been in existence for 5 years. - 2 We charge fixed fund charges that cover normal fund operating costs. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges. This may be shown as 0.00% due to rounding.
- 3 The top 10 investments listed in the table exclude current assets and current liabilities, and as a result do not sum to 100%.
