What is the purpose of this update?

This document tells you how the US 500 Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. 


Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted but before tax of \$1370 (that is 13.70% of their initial \$10,000). Jess paid other charges of \$12. This gives Jess a total return after tax of \$1259 for the year.

Notes

- 1 These charges refer to the normal fund operating costs that are charged to the fund. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges. Some of these are fixed costs so the amount shown can range from 0% up to the total fund charges depending on the total value of the fund.
- 2 The top 10 investments listed in the table exclude current assets and current liabilities, and as a result do not sum to 100%.



3 Anna Scott was appointed as Chief Executive Officer of Smartshares Limited on 4 September 2023, and replaced Graham Law, in his capacity as Acting Chief Executive Officer of Smartshares Limited, as a key person that has influence on the investment decisions of the fund.
