What is the purpose of this update?




Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted but before tax of \$747 (that is 7.47% of Jess's initial \$10,000). Jess also paid \$12 in other charges. This gives Jess a total return after tax of \$586 for the year.

1 These charges refer to the normal fund operating costs that are charged to the fund.
