What is the purpose of this update?




Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess incurred a loss after fund charges were deducted but before tax of -\$227 (that is -2.27% of Jess's initial \$10,000). Jess also paid \$12 in other charges. This gives Jess a total loss after tax of -\$390 for the year.
