# What is the purpose of this update?

This document tells you how the Australian Shares Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. 


# Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted but before tax of \$1,287 (that is 12.87% of Jess's initial \$10,000). Jess also paid \$12 in other charges. This gives Jess a total return after tax of \$1,158 for the year.

## **Currency hedging**

As at 27 June 2024 the fund's exposure to assets denominated in foreign currencies was 99.93%, of which 50.41% was hedged. This means the fund's unhedged foreign currency exposure was 49.55% of the net asset value of the fund.
