Fund update for the quarter ended 30 September 2024

This fund update was first made publicly available on 29 October 2024.

What is the purpose of this update?

This document tells you how the SuperLife High Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Invests in growth assets and is designed for investors that want an aggressive investment option that invests in shares and property. Negative annual returns may occur once in every 2-4 years on average.

Total value of the fund: \$166,149,940

Number of investors in the fund: 2,568

What are the risks of investing?

Risk indicator for the SuperLife High Growth Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


How has the fund performed?

Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted but before tax of \$2,111 (that is 21.11% of Jess's initial \$10,000). Jess also paid \$12 in other charges. This gives Jess a total return after tax of \$1,951 for the year.

Currency hedging

As at 30 September 2024 the fund's exposure to assets denominated in foreign currencies was 80.50%, of which 50.17% was hedged. This means the fund's unhedged foreign currency exposure was 40.11% of the net asset value of the fund. Notes

- These charges refer to the normal fund operating costs that are charged to the fund. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges. Some of these are fixed costs so the amount shown can range from 0% up to the total fund charges depending on the total value of the fund.
- 2 The 'other' category refers to an investment in infrastructure. The underlying investments are infrastructure securities listed in developed countries.
