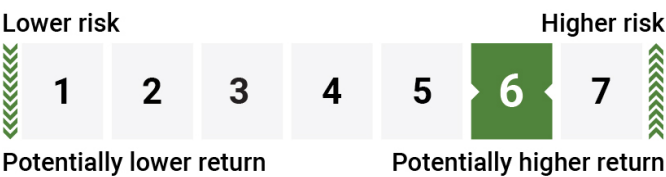
## Description of this fund

Invests in US shares and is designed to track the return (before tax, fees and other expenses) of the CRSP US Large Cap Growth Index.

## What are the risks of investing?

**Risk indicator for the US Large Growth Fund**



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

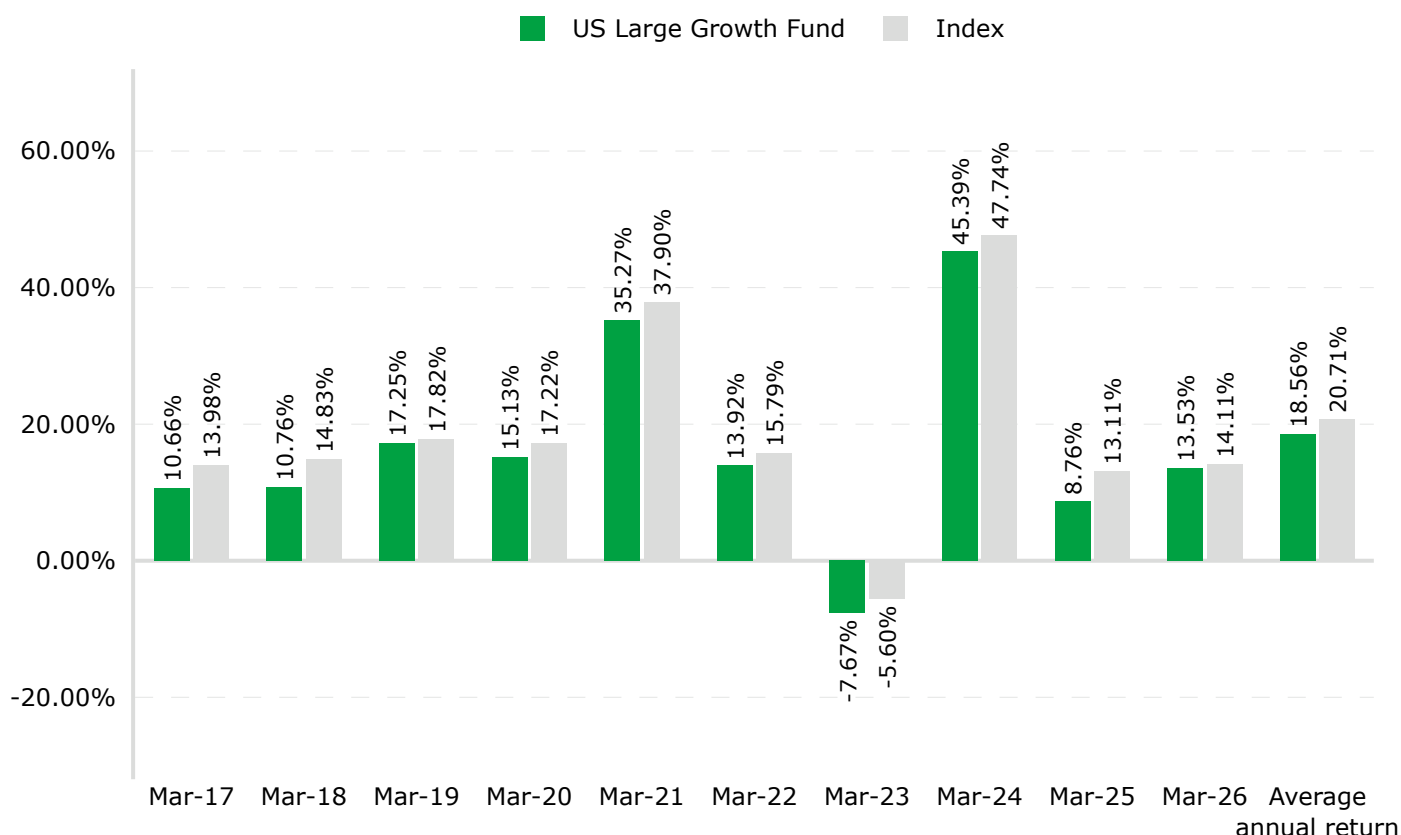

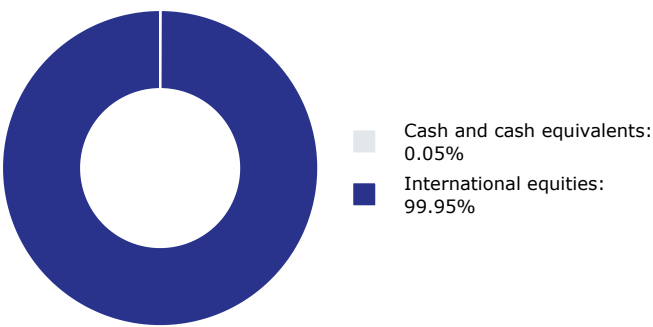
## Example of how this applies to an investor

Jess had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jess received a return after fund charges were deducted but before tax of \$2,499 (that is 24.99% of Jess's initial \$10,000). Jess also paid \$12.00 in other charges. This gives Jess a total return after tax of \$2,362 for the year.
